



# CONSENT TO CONDUCT BACKGROUND INVESTIGATION OF VOLUNTEERS

FOR AND IN CONSIDERATION of the mutual promises, the sufficiency of which is deemed sufficient, made by the person signing below, hereinafter "APPLICANT, " and Jasper County, South Carolina, its County Council, officers, members, employees, agents, assigns, contractors and all other persons, agencies, firms, corporations closely or remotely comlected with them (hereinafter "COUNTY,"), that are set forth herein:

Applicant acknowledges that he or she has applied to the County to provide volunteer services to the County. By signing this Agreement, Applicant consents and agrees to the County conducting a background investigation pertaining to the Applicant's qualifications and suitability for the volunteer position sought. The background investigation will include an investigation of criminal or police records, and may include financial/credit records, education records, driving records, and any other information deemed by the County to be material to filling the position sought.

The Applicant intends to and does hereby release any and all claims of any nature and kind whatsoever, known or unknown, which he or she may have or may accrue against the County on account of or in connection with the County's volunteer application, selection process and procedures and the performance of the investigation herein described . Applicant agrees that this Agreement shall apply to known and unknown and unanticipated damages resulting from or in any way connected with his or her application with the County.

This Agreement is contractual and not merely a recital. Applicant acknowledges and agrees that this Agreement was presented to Applicant in writing in sufficient time for Applicant to consider the contents of this Agreement; and that the Applicant has been advised to consult an attorney, if he or she so chooses, before signing this Agreement. By signing this Agreement, Applicant states that he or she has read and fully understands this Agreement; agrees that this Agreement is and shall be governed by the laws of the State of South Carolina and that should any dispute, claim, cause of action or litigation ensue from this Agreement, venue shall lie in the State of South Carolina's 14th Judicial Circuit in Jasper County, South Carolina.
